



24. Y N 24. A-1 dives to the floor for a loose ball and slides after gaining control. After A-1 comes to a stop, A-1 rolls over. Official rules this a traveling violation. Is the official correct?
25. Y N 25. While A-1 is dribbling, B-1 bats the ball away. A-1 recovers the ball and starts another dribble. Official rules this a legal play. Is the official correct?
26. Y N 26. Team A requests and is granted a time-out. After 10 seconds team A is ready to resume play. Official informs team A a time-out may not be shortened unless both teams are ready to play. Is the official correct?
27. Y N 27. Team B's assistant coach is charged with a technical foul and an indirect technical foul is charged to the head coach. Official rules both fouls count toward reaching the bonus. Is the official correct?
28. Y N 28. B-1 has obtained a legal guarding position on A-1 and is maintaining that position when A-1 contacts B-1 on the torso while B-1 has one foot off the floor. Official charges B-1 with a blocking foul. Is the official correct?
29. Y N 29. A-1 attempts a try for goal after ending the dribble. The try fails to hit the ring, backboard or any player. A-1 is able to catch the ball before it hits the floor. Official rules this a traveling violation. Is the official correct?
30. Y N 30. A-1 is straddling the three point arc when he/she picks-up the foot from in front of the arc and prior to placing it back on the floor behind the three point arc, A-1 tries for goal. Ball enters basket. Official rules this a two point try. Is the official correct?
31. Y N 31. While A-1 has the ball out of bounds for a throw-in following a goal, B-2 is charged with an intentional personal foul on A-2 near the end line. Following the free throws the official awards the ball to team A and allows them to run the end line. Is the official correct?
32. Y N 32. While A-1's try is in flight, a double personal foul is charged against A-2 and B-2. The ball enters the basket. Official counts the basket and uses the alternating possession procedure to resume play. Is the official correct?
33. Y N 33. A-1, while holding the ball in the frontcourt, passes toward A-2. B-1 deflects the ball which touches A-2 and goes into the backcourt. A-2 is the first to touch the ball in the backcourt. Official rules this a legal play. Is the official correct?
34. Y N 34. Following a time-out, team A is entitled to the throw-in, but continues to huddle. Official charges team A with a technical foul. Is the official correct?
35. Y N 35. A-1 is fouled and awarded two free throws. After the official reports the foul, B-6 reports to enter the game. Official beckons B-6 into the game. Is the official correct?
36. Y N 36. During a jump ball to start the first extra period, A-2 fouls B-2. Team B is in the bonus. Official instructs the scorer to set the possession arrow when the ball is placed at the disposal of B-2 for the first free throw. Is the official correct?
37. Y N 37. During a throw-in, A-1 holds the ball through the plane of the boundary line. B-1 slaps the ball from A-1's hands. Official charges B-1 with a technical foul. Is the official correct?
38. Y N 38. After the ten minute mark to begin the game the coach of team A adds one name to the squad list. The official assesses a technical foul. As the officials are about to start the game, the coach of team A changes two designated starters. The referee charges team A with another technical foul. Is the referee correct?
39. Y N 39. Airborne shooter A-1 fouls B-1 and the ball lodges between the ring and the backboard. Official resumes play using the alternating possession procedure. Is the official correct?
40. Y N 40. A-1 ends his/her dribble then passes to a cutting teammate. The ball is overthrown. Before any other player touches the ball, A-1 touches it. Official rules this a double dribble. Is the official correct?
41. Y N 41. During A-1's interrupted dribble in the frontcourt, official calls a three (3) second violation. Is the official correct?
42. Y N 42. A-1 and B-1 foul each other at approximately the same time while the ball is live. Official rules this a double personal foul. Is the official correct?
43. Y N 43. Before A-1 releases the ball on the first of a one and one, B-1 in a marked lane space steps into the lane, followed by A-2, who is also in a marked lane space. Official rules this a double free throw violation. Is the official correct?
44. Y N 44. Jumper A-1 taps the ball which touches one of the non-jumpers. A-1 then taps the ball two more times. Official rules this a violation for tapping the ball more than twice. Is the official correct?
45. Y N 45. A-1, while dribbling, intentionally pushes B-1. Official rules this a player control foul. Is the official correct?
46. Y N 46. A-1 catches A-2's pass then fumbles the ball, immediately recovers it and starts a dribble. A-1 ends his/her dribble and fumbles the ball again. A-1 recovers the ball. Official rules this a violation. Is the official correct?
47. Y N 47. A-1's throw-in is caught by A-2 with one foot on the floor in the frontcourt. A-2 then places the other foot down in the backcourt. Official rules this a legal play. Is the official correct?
48. Y N 48. A-1 commits his/her fifth foul and disqualified. Prior to replacing A-1, team A request a time-out. Official grants the request. Is the official correct?
49. Y N 49. B-1 is behind A-1 moving in the same path and same direction. A-1 stops so quickly that B-1 cannot stop and contacts A-1. Official calls a foul on A-1. Is the official correct?
50. Y N 50. Jumper A-1 taps the ball which is touched simultaneously by A-2 and B-2 and goes out of bounds. Official has the original jumpers, jump to resume play. Is the official correct?
