(All questions are based on National Federation Rules)

This examination will be given on Monday, November 7, 2005. This examination is presented in a “Yes-No” format. Carefully read each situation described. If the answer is “YES,” draw a circle around the “Y.” If the answer is “NO,” draw a circle around the “N.” The rulebook may not be used during the examination. In order to pass, the examinee must correctly answer a minimum of 43 questions. Having passed this examination, the candidate is eligible for the floor examination.

NOTE: “In the act of shooting” on this examination means the ball is still in the hands of the shooter. “Tap,” for this examination only, is defined as “the same as a try.”

| 1. Following a score, A-1 has the ball out of bounds for the throw-in when B-2 commits a common foul near the end line. Team A is not in the bonus. Official awards team A the ball and rules team A retains the privilege of running the end line. Is the official correct? | 1. | Yes | No |
| 2. B-1 is charged with an intentional personal foul. Official awards A-1 two free throws plus the ball at the spot nearest the foul. Is the official correct? | 2. | Yes | No |
| 3. A-1 lifts his/her pivot foot before releasing the ball on a pass. Official calls a traveling violation on A-1. Is the official correct? | 3. | Yes | No |
| 4. B-1 rebounds a missed shot at A-1's basket and passes the ball toward the division line. A-1 jumps from his/her frontcourt and secures control while both feet are off the floor. A1 lands in backcourt. Official rules this a backcourt violation. Is the official correct? | 4. | Yes | No |
| 5. Airborne shooter A-1 is fouled prior to returning to the floor. Official rules A-1 was fouled in the act of shooting. Is the official correct? | 5. | Yes | No |
| 6. Prior to the game, team A is assessed a technical foul. When the official places the ball at the disposal of B-1 for the first free throw the official has the scorer set the possession arrow toward team A's basket. Is the official correct? | 6. | Yes | No |
| 7. B-1 fouls A-1 and is awarded a one and one. As the official is reporting the foul, A-1 is charged with a technical foul. After all the free throws are completed, official uses the alternating possession procedure to resume play. Is the official correct? | 7. | Yes | No |
| 8. After A-1 commits a foul, A-1 removes his/her jersey. Official charges A-1 with a technical foul. Is the official correct? | 8. | Yes | No |
| 9. A-1 commits his/her fifth foul and is disqualified. Prior to team A coach replacing A-1, team A requests a time-out. Official grants the request. Is the official correct? | 9. | Yes | No |
| 10. A-1, dribbling in the backcourt, has the ball batted away by B-1. Official continues the 10 second count. Is the official correct? | 10. | Yes | No |
| 11. B-1 reaches through the plane of the boundary line and fouls thrower-in A-1. Official charges B-1 with an intentional personal foul and issues a warning to team B. Is the official correct? | 11. | Yes | No |
| 12. While A-1's try is in flight the official inadvertently sounds the whistle. Ball enters basket. Official disallows the basket. Is the official correct? | 12. | Yes | No |
| 13. A-1's throw-in is tapped into the backcourt by A-2, who is in the frontcourt. A-1 is the first to touch the ball in the backcourt. Official rules this a backcourt violation. Is the official correct? | 13. | Yes | No |
| 14. B-1, in an attempt to stop a bounce pass, extends his/her leg toward the ball. Ball hits B-1 in the thigh. Official rules this a kicking violation. Is the official correct? | 14. | Yes | No |
| 15. While A-1's try is in flight, A-2 fouls B-2. The try is successful. Team B is not in the bonus. Official rules team B's throw-in is a designated spot throw-in. Is the official correct? | 15. | Yes | No |
| 16. A-1, who is straddling the three point line, picks up the foot inside the line and prior to placing it back on the floor outside the line, A-1 tries for goal. Official rules this a two point try. Is the official correct? | 16. | Yes | No |
| 17. A-1 receives the ball while in the air. A-1 lands on the left foot, jumps off that foot and lands simultaneously on both feet. Official rules this a traveling violation. Is the official correct? | 17. | Yes | No |
| 18. Prior to A-1 attempting his/her first free throw of two, A-6 reports to the scorer's table to substitute for A-2. The scorer sounds the horn and the official beckons A-6 into the game. Is the official correct? | 18. | Yes | No |
| 19. A-1's try hits the ring and bounces straight up in the imaginary cylinder above the ring level, when B-1 touches the basket. Official rules this basket interference. Is the official correct? | 19. | Yes | No |
| 20. A-1 while holding the ball inbounds touches a knee to the floor. Official rules a traveling violation on A-1. Is the official correct? | 20. | Yes | No |
| 21. While A-1 is dribbling, A-2 is charged with a common foul. This is team A's seventh foul of the half. Official awards team B a one and one. Is the official correct? | 21. | Yes | No |
| 22. A-1's throw-in is caught by A-2 with one foot on the floor in the frontcourt. A-2, then places the other foot down in the backcourt. Official rules this a legal play. Is the official correct? | 22. | Yes | No |
| 23. A-6 leaves the bench and enters the court as it appears a fight may breakout. Official charges A-6 with a flagrant technical foul, banishes him/her to the bench and charges the head coach with an indirect technical foul. Is the official correct? | 23. | Yes | No |

24. Yes No 24. A-1 has the ball out of bounds during an alternating possession procedure throw-in. A-1 commits a throw-in violation. Official awards the ball to team B and instructs the scorer to turn the arrow toward team B's basket. Is the official correct?
25. Yes No 25. While the ball is at the disposal of A-1 for a throw-in, A-2 commits a common foul on B-2. This is team A's seventh foul of the half. Official awards B-2 a one and one. Is the official correct?
26. Yes No 26. While A-1 is in the act of shooting and before releasing the ball, A-2 fouls B-2. A-1 continues the motion and scores. Official disallows the basket and penalizes the foul. Is the official correct?
27. Yes No 27. A-1 lifts his/her pivot foot off the floor prior to releasing the ball in starting his/her dribble. Official calls a traveling violation on A-1. Is the official correct?
28. Yes No 28. While A-1's try is in flight, A-2 commits a personal foul on B-2. Team B is in the bonus. Official awards B-2 a one and one. Is the official correct?
29. Yes No 29. B-1, while playing the ball causes excessive contact. Official rules this an intentional personal foul. Is the official correct?
30. Yes No 30. A-6 legally enters the playing court to replace A-5. As A-5 is leaving the court, A-5 is assessed a technical foul. Official rules A-5 is bench personnel and charges an indirect technical foul to the coach. Is the official correct?
31. Yes No 31. Following a time-out, team A, entitled to a throw-in, continues to huddle. Official calls a technical foul on team A for delay of game. Is the official correct?
32. Yes No 32. A double personal foul is charged while team A is in control. Official awards the ball to team A nearest the spot of the foul. Is the official correct?
33. Yes No 33. During a jump ball to start the game, jumper A-1 taps the ball which is touched by a non-jumper. Jumper A-1 then catches the ball. Official rules this a violation. Is the official correct?
34. Yes No 34. Team B is charged with a technical foul prior to the game. Coach of team A request that A-6 replace designated starter A-1 to attempt the free throws. Official allows A-6 to enter the game. Is the official correct?
35. Yes No 35. A-1, closely guarded in the frontcourt, dribbles the ball for 4 seconds then holds the ball. Official starts a new count. Is the official correct?
36. Yes No 36. Team control begins when the ball is at the disposal of the team entitled to the throw-in. Is this correct?
37. Yes No 37. A-1 is to attempt a free throw and B-1 and B-2 occupy the first marked lane spaces. Team A chooses not to occupy the second marked lane spaces. B-3 and B-4 request permission to occupy these spaces. Official denies the request. Is the official correct?
38. Yes No 38. Three substitutes from team A are beckoned into the game. Captain of team B request a defensive match up. Official grants the request. Is the official correct?
39. yes No 39. A-1 leaves the playing court for an unauthorized reason. Official rules this a violation. Is the official correct?
40. Yes No 40. During a jump ball to start the game, A-1's tap is simultaneously deflected out of bounds by A-2 and B-2. Official has the original jumpers re-jump to resume play. Is the official correct?
41. Yes No 41. Thrower-in A-1 places the ball through the plane of the boundary line. Defender B-1 slaps the ball out of A-1's hands. Official charges B-1 with a technical foul. Is the official correct?
42. Yes No 42. As the ball comes through the net on a field goal by A-1, A-2 gives the ball a tap so team B cannot readily make the throw-in. Official issues a warning to team A for delay for interfering with the ball. Is the official correct?
43. Yes No 43. A-1 is charged with a technical foul. Official rules that the foul counts toward the five fouls for disqualification and also counts toward reaching the bonus. Is the official correct?
44. Yes No 44. A-1 is dribbling near the side line and makes contact on the front of B-1's torso who has one foot touching the boundary line. Official charges A-1 with a player control foul. Is the official correct?
45. Yes No 45. A-1 dribbling from backcourt to the frontcourt has both feet in the frontcourt while the ball is being dribbled in the backcourt. Official continues the 10 second count. Is the official correct?
46. Yes No 46. A-1 is erroneously awarded a one and one. A-1 makes the first free throw and misses the second which is rebounded by B-1, who passes to B-2, who scores. The error is now recognized before the ball is at the disposal of team A. Official cancels the free throw, counts the basket and resumes play from the point of interruption. Is the official correct?
47. Yes No 47. While the ball is dead, A-1 and B-1 foul each other at approximately the same time. Official rules this a double personal foul. Is the official correct?
48. Yes No 48. A-1 is fouled while tapping a rebound toward his/her basket. Ball enters basket. Official counts the basket and awards A-1 one free throw. Is the official correct?
49. Yes No 49. A-6 replaces A-1. During team B's throw-in, team B is granted a time-out. During the time-out A-1 reports to replace A-2. Official allows the substitution. Is the official correct?
50. Yes No 50. While A-1's free throw is in flight and prior to the ball hitting the ring, backboard or the free throw ending, B-1 steps into the lane. A-1's free throw fails to hit the ring. Official rules this a double free throw violation. Is the official correct?
