



23. Y N 23. Thrower-in A-1 touches the boundary line without breaking the inside edge. Official sounds the whistle and rules this a throw-in violation. Is the official correct?
24. Y N 24. While player A-1 is dribbling, A-2 commits a common foul. Official rules this a team control foul. Is the official correct?
25. Y N 25. While playing the ball, B-1 causes excessive contact on A-1's drive to the basket. Official rules this an intentional personal foul. Is the official correct?
26. Y N 26. A-1 and B-1 are jumpers to start the game. A-1's tap is caught by A-2 while airborne from the frontcourt, A-2 lands in backcourt. Official rules this a legal play. Is the official correct?
27. Y N 27. Team A is awarded the ball for an alternating possession throw-in. Prior to the alternating possession procedure ending, team A commits a throw-in violation. Official rules team A loses the ball plus the arrow. Is the official correct?
28. Y N 28. On a free throw by A-1, B-1 and B-2 occupy the first marked lane spaces. Team A chooses not to occupy the second marked lane spaces. Team B requests permission to occupy these spaces. Official denies the request. Is the official correct?
29. Y N 29. While A-1's try is in flight, a double personal foul is assessed. The try is unsuccessful. Official resumes play with the alternating possession procedure. Is the official correct?
30. Y N 30. While the ball is in the air on a jump ball, B-2 fouls A-2. Official rules B-2's foul is a technical foul. Is the official correct?
31. Y N 31. During A-1's interrupted dribble, team A requests a timeout. Official grants the request. Is the official correct?
32. Y N 32. Five minutes prior to the scheduled starting time, team A submits its squad list and starting lineup. Referee assesses team A with two technical fouls. Is the referee correct?
33. Y N 33. A-1 while dribbling in the backcourt has the ball batted away. A-1 retrieves the ball. Official starts a new 10-second count. Is the official correct?
34. Y N 34. With team A winning 54-53, A-1 taps the ball toward team B's basket. The horn sounds ending the fourth quarter, the ball enters the basket. Official counts the goal. Is the official correct?
35. Y N 35. During a throw-in team A lines up three players side by side at a distance less than 3 feet from a boundary line and parallel to it. Captain of team B requests positions between the A players. Official denies the request. Is the official correct?
36. Y N 36. While A-1 is in the air to try for goal, A-1 voluntarily drops the ball to the floor. A-1 is the first to touch the ball. Official rules this a traveling violation. Is the official correct?
37. Y N 37. A-1 fouls B-1 while A-2 is in the act of shooting. Ball enters basket. Official disallows the basket. Is the official correct?
38. Y N 38. A-1 commits his/her fifth foul. As A-1 is leaving the playing court, A-1 pulls his/her jersey over his/her head. Official charges A-1 with a technical foul. Is the referee correct?
39. Y N 39. A-1 is called for traveling. Official sounds the whistle and glances at the clock. Three seconds is showing but the timer stops the clock with 2 seconds remaining. Official rules no timing mistake has occurred and makes no correction. Is the official correct?
40. Y N 40. A-2 fakes entering the lane while A-1's free throw is in flight and before the ball hits the ring, backboard or the free throw ending, causing B-1 to enter the lane. Official penalizes the fake only. Is the official correct?
41. Y N 41. A-1 is charged with a technical foul. Official informs the scorer the technical foul counts toward the five fouls for disqualification and to reach the bonus. Is the official correct?
42. Y N 42. A-1, who is behind the 3-point arc, jumps into the air to attempt a 3-point try. Prior to releasing the ball, A-1 breaks the plane of the 3-point arc. Ball enters basket. Official rules this a 2-point goal. Is the official correct?
43. Y N 43. A-1 in an attempt to maneuver around a double screen intentionally goes out of bounds. Official calls a violation on A-1 as soon as he/she steps out of bounds. Is the official correct?
44. Y N 44. A-1 is fouled and awarded a one and one. As the official is ready to administer the free throw, A-1 is huddling with his/her teammates behind the semicircle. Official uses the resumption of play procedure to resume play. Is the official correct?
45. Y N 45. A-1's try is touched on its upward flight. Time expires as the ball is in flight. Ball enters basket. Official counts the goal. Is the official correct?
46. Y N 46. Thrower-in A-1 passes to A-2. A-2 immediately passes to A-1, who has one foot inbounds and the other foot is in the air over the boundary line. Official rules this an out of bounds violation. Is the official correct?
47. Y N 47. Substitute A-6 is beckoned into the game to replace A-5. When A-6 legally enters the playing court, A-5 becomes bench personnel. Is this correct?
48. Y N 48. While A-1 has the ball for a throw-in, A-2 commits a common foul against B-2. Team B is in the bonus. Official awards B-2 a one and one. Is the official correct?
49. Y N 49. The warning horn has sounded 15 second prior to the expiration to end the intermission. After the warning horn, A-6 reports to enter the game. Official rules A-6 may report to enter at any time up until the final horn that ends the intermission. Is the official correct?
50. Y N 50. As the official bounces the ball to A-1 for a throw-in and prior to A-1 catching the ball, B-1 requests a timeout. Official grants the request. Is the official correct?
